

The institutionalization of gender mainstreaming in the organization and the working of an administration

Article 3 of the law of 12 January 2007 explicitly entrusts each minister with watching over « the integration of the gender dimension in management plans and management contracts as well as in any other instrument of strategic planning of the federal public services (...) for which he/she is qualified. »

This third thematic seminar will deal with the organization and the working of federal administrations within the scope of the implementation of the provisions of the law of 12 January 2007 on the integration of the gender dimension in the federal administrations.

A Belgian expert will present the methods, techniques and tools useful for the integration of the gender dimension in the organization and working of an administration, and specifically focus on management, internal coordination, integration of gender in management tools, staff sensitization and training, human resources management, knowledge management and communication.

The seminar will also offer the opportunity to touch upon the integration of the gender dimension in the procedures for the assignment of public spending contracts.

Two foreign experts (Austria - Spain) will then present a concrete experience related to the integration of the gender dimension in the organization and working of an administration.
