





- 1 EUR = 7,41 HRK







- o registration of vehicles in Croatia within 3 months.


 In some sectors free accomodation offered close to the work place (tourism, seasonal work).

Entry and stay in Croatia

EU nationals

- ID card (no need for passport)
- entitled to stay in the Republic of Croatia up to 3 months from the day of their entry (no need to declare the reason for stay)
- not later than 8 days following the expiration of first 3-month stay period a temporary stay has to be reported at a competent police administration/police station

Certificate of reporting a temporary stay will be issued for the purpose of:

- o work, selfemployment
- study or vocational training
- family reunion
- other purpose (health insurance, sucifient means).

Permanent stay:

after 5 years of an uninterrupted legal stay.





Searching for a job

- websites
 - www.hzz.hr (croatian employment service)
 - EURES portal
 - <u>www.moj-posao.net</u>, <u>www.posao.hr</u> (private)
 - private employment agencies websites (DEKRA, Adecco)
 - companies websites
- o news papers, radio stations
- sending open applications (without published vacancy).

Application:

- CV and cover letter email, post, in person (in English, German...)
- o online interviews.

Agency work – not very common.

Seasonal employment:

- tourism (coast, March October)
- agriculture (picking fruits additional source of income)
- construction
- o industry.





Labour market needs

Production:

- metal workers (locksmiths, welders, sheet metal workers, metal construction assemblers) – often posted abroad
- CNC programers and operators
- Engineers and programmers car industry

Construction:

masons, carpenters, joiners, roofers – often posted abroad.

Transport:

o truck drivers, bus drivers.

Tourism:

- o cooks, kitchen helpers, waiters, room maids
- tourist entertainers (seasonal jobs, winter season abroad Thailand...)

Often no need for related education or experience.





Taking up an employment

- employment contract in writing
- registration at insurance authorities (pension, health) employer's obligation,
 before employmet starts
- consecutive temporary employment contracts possible for up to 3 years
- ending employment notice in writing (notice period at least 2 weeks)
- protection of workers' rights labour inspection, trade unions
- full working time 40 hours (8 hours/day)
- daily rest 30 min (paid)
- annual leave minimum 4 weeks





Taking up an employment

Accommodation

Employers are aware that seasonal workers need accommodation and most of them offer a room or a shared apartment which could be for free or with minimum cost. Larger companies usually have secured accommodation for their employees. Tourist entertainers and animators are accommodated in hotels and camps where they work.

Meals

 At least one meal, if not all three, is offered for free and additional meals won't cost much. Meals are provided in restaurants for personnel which is (most of the time) near working location.





Earnings

Salaries (2019)

- paid monthly to bank account
- social insurance contributions pension 20%, health 16.5%, accident 0,7% (deducted from the salary)
- tax
 non-taxable 4.000,00 HRK (539 EUR)
 24% up to 17.500,00 HRK (2361 €)
 36 % above 17.500,00 HRK
- o proscribed minimum wage net 3.250 HRK (438 EUR)
- o proscribed minimum wage gross 4.062 HRK (548 EUR)
- average net salary for 2019 6.456 HRK (871 EUR)
- o average gross salary for 2019 8.765 HRK (1.182 EUR).





Costs of living

- o Bread 6-12 HRK (0,80-1,6 EUR)
- Meat 30-120 HRK (4,50-16 EUR)
- Pizza 40-80 HRK (5,50-10.50 EUR)
- Water (bottled, 1L) 6 HRK (0,80 EUR)
- Juice 1L 10-12 HRK (1,50 EUR)
- Beer (0,5) store 10 HRK / bar from 15 HRK (1,50/2 EUR)
- Cinema (ticket) 35 HRK (5 EUR)
- Gas 8 HRK* (1,20 EUR)
