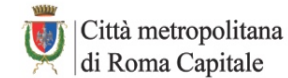


Reactivate provides a set of services:

- ✓ financial support to jobseekers for an interview trip abroad, language training, recognition of qualifications and relocation expenses (also for the family members)
- ✓ financial support to SMEs to cover some training and integration costs.

Reactivate services are free of charge and tailor-made to employers and jobseekers needs.

All EU employers are eligible: public and private sector / small-medium-large sized.

Small and medium-sized enterprises (SMEs) may be given enhanced services, including **financial support** to cover some training and integration costs.

Employers from all economic sectors can benefit from Reactivate services.
